NOTICE CALLING FOR SUBMISSION OF REPRESENTATIONS ON INTENTION TO AMEND
THE CONTRACT FOR SUPPLY, INSTALLATION, CONFIGURATION, SERVICE AND
MAINTENANCE OF ON PREMISES IP PBX TELEPHONE MANAGEMENT SYSTEM WITH VPN
CONNECTIVITY

A notice is hereby given in terms of section 116 (3) (b)(i) and (ii) of the Municipal Finance Management Act, 2003 (Act 53 of 2003), read in conjunction with Section 21A of the Municipal Systems Act, 2000 (Act no. 32 of 2000) that Molemole municipality intends to extend the service level agreement for a further period of thirty-six (36) months. The proposed intention for contract extension was tabled and approved by Council in a meeting held on the 30th August 2023 in line with section 116 (3) (a) of the Municipal Finance Management Act, 2003 (Act 56 of 2003), council resolution number: SC/3.3.4/30/08/20234

Molemole Local Municipality has appointed Telkom SA SOC LIMITED for a period of thirty-six months, through a competitive bidding process as required in line with the Supply Chain Management policy and the Municipal Supply Chain Regulations (2005), for the supply, installation, configuration, service and maintenance of on premises IP PABX Telephone Management System with Virtual Private Network (VPN) connectivity.

The telephone management system assists the municipality to connect with employees in all the eight (8) municipal service points through VPN connectivity at no cost to the municipality. The telephone management system further assists the municipality to interact with all the


relevant municipal stakeholders (Community members, private entities, civil society organizations and other sister government institutions) on routine and key service delivery mandates of the municipality. The Service Level Agreement (SLA) entered with Telkom SOC Limited is set to expire on the 11th November 2023 and the Municipality intends to extend the SLA by a further thirty-six (36) months, effective from the 12th November 2023. An extension of this SLA will save costs associated with procuring new system in order to replace the old system and will ensure uninterrupted provision of municipal services.

The local community is hereby invited to make comments on the proposed contract extension with Telkom SLA for provision of Telephone Management system for a further period thirty-six months.
