MOLEMOLE MUNICIPALITY IS HEREBY INVITING QUOTATIONS FROM PROSPECTIVE SERVICE PROVIDERS WHO ARE REGISTERED ON THE CENTRAL SUPPLIER DATABASE (CSD) FOR IDENTIFICATION OF PEGS OF 180 IN DENDRON (MOGWADI EXTENSION 3).

It is against this background that Molemole Local Municipality invites suitably qualified practitioners/service providers to bid for the following:

- Identification of pegs of 130 sites in Dendron Extension 3.
- The sites measurements ranges from 705 m² to 1030m² in extent

The appointed service provider will be expected to re install the pegs using 200mm steel droppers and affix them on the with cement.

1. The following documentation should be attached to the quotations:

- a. The recent up-to-date central supplier data (CSD) registration report detailing all compliance requirements; [Last verified between the advert date and the closing date]

- f. Fully signed and completed MBD 6.2 certificate and Annex C for local content and production [downloadable from www.molemole.gov.za] If Applicable


4. Evaluation on functionality
