Bids received by telegram, fax or e-mail will not be considered. Late bids shall neither be accepted nor considered.

A preferential point system shall apply whereby this contract will be allocated to a bidder in accordance with the **Preferential Procurement Policy Framework Act, Act No. 5 of 2000** and in consideration of other conditions as set out in the bid document, read in conjunction with the **Supply Chain Management Policy** of Molemole Local Municipality. A 90/10 points system shall apply in respect of this bid where 90 points will be allocated in respect of price and functionality whilst 10 points will be allocated towards targeted goals.
