Molemole Local Municipality, invites tenders for the following works at the stated taxi ranks in the Municipality:

LOT 1: UPGRADING OF MACHAKA, RAMOKGOPA AND MAKGATO TAXI RANK

- Construction of the new 1.8m high Palisade fence with a perimeter of 670 meters.
- Rehabilitation of the Ablution Block

LOT 2: UPGRADING OF MOREBENG TAXI RANK

- Construction of the new 1.8m high Palisade fence with the perimeter of 700 meters.
- Construction of hump
- Rehabilitation of the Ablution Block

LOT 3: CONSTRUCTION OF RAMOKGOPA TO EISLEBEN TAXI RANK

- Construction of paved road furniture for a two bay taxi rank
- Construction of shelter over the two bays complete with lights
- Construction of 1.8m high Palisade fence with the perimeter of 220 metres
- Construction of separate male and female VIP toilets

LOT 4: PROVIDE AND INSTALL BUS SHELTERS AT DESIGNATED POINTS IN RAMOKGOPA AND EISLEBEN

Tenderers can submit tenders for one or more of the above stated Lots. Each Lot will be awarded as a separate individual contract.

Only Tenderers that have a CIDB contractor grading of 2 or higher are eligible to submit bids. Joint ventures are also eligible to submit bids provided every member of the Joint Venture is registered with CIDB and a combined grade of the Joint Venture calculated in accordance with the construction industry development regulations is equal to or higher than a contractor grading of 3.

Tender documents will be available during office hours (between 07h30 and 15h00) as from Friday 18 June 2010 at the office of the Molemole Local Municipality, 303 Church Street, MOGWADI. A non-refundable fee of R 150.00 is payable to secure a copy of the tender document.
