## INVITATION TO SERVE AS MEMBERS OF THE AUDIT COMMITTEE

Molemole Local Municipality hereby invites all independent, suitably qualified and experienced candidates to serve as members of the Audit Committee. The Committee will constitute a maximum of four (4) members.

**Requirements:** Applicants should have a relevant degree or equivalent qualification in Auditing/Accounting, Law, Information Technology (ICT) and Public Administration. Experience in any of the following fields Internal Auditing, Risk Management, Finance, Performance Management, Legal, Human Resources and Information Technology. The applicants should have appropriate knowledge and experience in local government.

**Responsibilities:** The Audit Committee in terms of the Municipal Finance Management Act shall: Review the coordination of audit efforts to ensure the completeness of coverage and promote the effective use of financial resources. Review the adequacy and effectiveness of the system of internal control. Review the quality of financial information and other relevant information submitted by management including the recommendations by Internal Audit and Auditor General. Review the Annual Financial Statements prior submission to AGSA. Review the overall level of compliance with MFMA, the Division of Revenue Act and any other applicable legislations.

**Term of office and remuneration:** Appointment will be for a period of three (3) years and may be subject to renewal at the discretion of Municipal Council. Remunerated will be paid in accordance with National Treasury Regulations 20.2.2. State employees will only be remunerated out of pocket expenses. Applicants should not serve on more than three local government Audit Committees.
