### **NOTICE OF INTENT: CALLING FOR SUBMISSION OF REPRESENTATIONS ON INTENTION TO AMEND THE CONTRACT FOR SOLAR FINANCIAL SYSTEM**

A notice is hereby given in terms of Municipal Finance Management Act, 2003 (Act 53 of 2003) section 116 (3)(a) (b)(i) (ii) read with Section 21A of the Municipal Systems Act No. 32 of 2000 that the municipality intends to amend the main contract to include license fees for the Budget Module effective from the 2025/2026 financial year.

The reason for the extension was tabled and approved in the Council meeting held on the 27<sup>th</sup> June 2025(SC27/06/2025//3.6.3.4).

Molemole Local Municipality has appointed Business Connection (BCX) for the supply, support and maintenance of Solar Financial system, in line with the Supply Chain Management policy and the Municipal Supply Chain Regulations (2005). The two parties have signed a Service Level Agreement (SLA).

The municipality has added a budgeting module to the main agreement to help with migrating budgeting processes from manual to electronic budgeting system. The migration is assisting the municipality to maintain integrity of the municipal budget and to avoid unauthorized expenditure. The addition of the budgeting module will lead to an increase in licensing fees effective from 2025/2026 financial year
