PUBLIC NOTICE

NOTICE OF INTENT: CALLING FOR SUBMISSION OF REPRESENTATIONS ON INTENTION TO AMEND THE CONTRACT FOR TECH-002/2024/25: SEKONYE TO SPRINGS UPGRADING OF INTERNAL STREETS FROM GRAVEL TO SURFACING

A notice is hereby given in terms of section 116 (3) (a) (b) (i) of the Municipal Finance Management Act, 2003 (Act 53 of 2003) read in conjunction with Section 21A of the Municipal Systems Act, 2000 (Act No. 32 of 2000) that the municipality intends to amend the contract for the abovementioned project. The reasons for the amendment were tabled and approved in a Council meeting held on the 30th January 2026. The municipality had appointed Raesibe Infrastructure Projects to Construct Sekonye to Springs Upgrading of 5km Internal Streets Phase 2 on a multi-year contract for implementation in the 2025/2026 and 2026/2027 financial years. The initial contract terms stipulated that 2km will be implemented in 2025/2026 and the final 3km to be implemented in 2026/2027 financial year.

The Municipality hereby wishes to bring the 3km forward for implementation due to availability of Budget following Budget Adjustment Process. The contract amendment will help the municipality to complete the full in one financial year instead of the initial two financial years. The amendment of the contract will not have any additional financial obligations for the municipality. The local community is hereby invited to make comments and representations on the envisaged contract amendment within 14 days from the date of the notice and should be submitted on or before 22nd February 2026.
