NOTICE OF INTENT: CALLING FOR SUBMISSION OF REPRESENTATIONS ON INTENTION TO AMEND THE CONTRACT FOR SUPPLY, INSTALLATION, CONFIGURATION, SERVICE AND MAINTENANCE OF ON PREMISES IP PBX TELEPHONE MANAGEMENT SYSTEM WITH VPN CONNECTIVITY- PROJECT NUMBER: MLM/CORP/03/2018/19

A notice is hereby given in terms of Municipal Finance Management Act, 2003 (Act 53 of 2003) section 116 (3)(a) (b)(i) (ii) read with Section 21A of the Municipal Systems Act No. 32 of 2000 that the municipality intends to extend the service level agreement for a period of thirty six (36) months.

The reason for the extension was tabled and approved in the Council meeting dated 30 August 2023.

Molemole Local Municipality has appointed Telkom SA SOC LIMITED for a period of thirty-six months, through a competitive bidding process as required in line with the Supply Chain Management policy and the Municipal Supply Chain Regulations (2005) for supply, installation, configuration, service and maintenance of on premises IP PABX Telephone Management System with VPN connectivity.

Implementation of Telephone Management system assist the municipality to ensure that there is communication flow between municipal officials, community members and other organs of the state effectively and efficiently in ensuring that service delivery is achieved. The two parties have entered into a Service Level Agreement (SLA) that commenced on the 06 June 2019 and is to come to an end on the 11th November 2023 as guided by the commissioning certificate.

Accordingly, an extension of the SLA with Telkom SA SOC LIMITED will ensure continuity in the implementation of IP PBX Telephone Management System across all municipal offices.

Furthermore, an extension of the SLA will save costs of training employees on new system as well as costs associated with procuring new system in order to replace the old system

The local community is hereby invited to make comments and representations within 07 consecutive days from the date of the notice, on or before 06 September 2023.
