PUBLIC NOTICE **NOTICE OF INTENT: CALLING FOR SUBMISSION OF REPRESENTATIONS ON INTENTION** **TO EXTEND THE CONTRACT FOR PERFORMANCE MANAGEMENT SYSTEM**

A notice is hereby given in terms of section 116 (3) (a) (b)(i) (ii) of the Municipal Finance Management Act, 2003 (Act 56 of 2003), read in conjunction with Section 21A of the Municipal Systems Act, 2000 (Act No. 32 of 2000) that the municipality intends to extend the service level agreement for the performance management system for a period of thirty-six (36) months. The reason for the need to extend the Service Level Agreement was tabled and approved in a Council meeting dated 30/01/2025, **Council Resolution number: OC/4.1.6/30/01/2025**

The municipality had entered into a thirty six (36) months service level agreement with CCG Systems for the supply, install and management of MSCOA-compliant Performance Management System. The service level agreement commenced in March 2022 and is set to expire on the 28th February 2025.

Since Implementation of the system the municipality has been storing and updating performance related information for the past three (3) years on the system. The municipality would like to continue with the system as all employees have received extensive training on the use of the system and to ensure continuation of performance management and evaluations of employees. Performance Monitoring and is critical to determine the contribution of each employee to the overall service delivery to the community of Molemole and to determine training interventions on areas of inadequate performance. The envisaged extension of the contract is on the same terms and conditions of the original contract.

The local community is hereby invited to send comments and representations on the envisaged extension within 21 consecutive days from the date of the notice. The due date for submission of comments and representations is 16H00, 20 February 2025.
