**NOTICE OF INTENT: CALLING FOR THE SUBMISSION ON INTENTION TO
EXTEND THE CONTRACT FOR THE PROVISION OF PROFESSIONAL LEGAL
SERVICES BY A PANEL OF ATTORNEYS REPRESENTING THE MUNICIPALITY**

A notice is hereby given in terms of section 116(3) (a) (b) (i) (ii) of the Municipal Finance Management Act, 2003 (Act 56 of 2003), read in conjunction with Section 21A of the Municipal Systems Act, 2000 (Act No.32 of 2000) that the municipality intends to extend the service level agreement (SLA) for the 5 Panel of attorneys for a period of three (3) months. The reason for the need to extend the Service Level Agreement was tabled and approved in a Council meeting dated 15/05/2026, **Council Resolution number: FC/15/05/2026/3.1.3**

The municipality had ended into a thirty six (36) months Service Level Agreement with 6 panel of attorneys to render the municipality Legal Assistance. The Service Level Agreement commenced on the 1st of September 2022 and was set to expire on the 31st of August 2025. The Panel of attorneys were extended for a further period of 3 months, the extension commenced on the 1st of March 2026 and is set to expire on the 31st of May 2026.

- The Municipality has derived joy from the various law firms that are defending the organization in all types of litigation
- The municipality sees the need to extend the contact for a further 3 months (from 1 June 2026 to 31 August 2026) as we are embarking upon supply chain processes in order to appoint a new panel of attorneys.

The envisaged extension of the contract is on the same terms and conditions of the original contract.

The local community is hereby invited to send comments and representation on the envisaged extension within 7 consecutive days from the date of Notice.
