- b) The municipality will pay a lump sum amount from the start of the agreement and the contract will automatically terminate at the end of the 12th Month
- c) The appointed Service Provider is expected to install the tracking devices in Mogwadi and Morebeng (Soekmekaar) offices
- d) The municipality may request to add or remove vehicles after acquiring new ones or disposing old ones, respectively.
- e) The option quoted should allow the Fleet Officer to:
 - i. Generate log books
 - ii. Live tracking of the vehicle
 - iii. Advice when service is due
 - iv. Easy, convenient and accessible on the mobile phone.

- f) Prices (s) must be firm and be inclusive of VAT (if applicable)
- g) A firm delivery period must be indicated.
- h) Quotations will be evaluated according to 80/20 points system whereby 80 points will be for price and 20 points will be allocated in line with Preferential Procurement Policy framework, 2000 and BBBEE regulations;

- j) Quotations must include all the items specified above and any incomplete quotes will be rejected;
